The increased number and weight of wagons using the B5301 cause for concern, when the proposed new Sand Quarry at Goodyhills, is allowed to go ahead this will increase the number of heavy sand vehicles and have a

detrimental effect on the road surface, contact portfolio holder for Highways and Cumberland Highways Department

Juliet Wise, Low Tarns Farm, asked if a weight restriction could be put on the narrow road between B5301 and Tarns/Holme St Cuthbert Road, large vehicles have twice caused damage to stone wall opposite this junction
